12. Cookies - online interfaces

In order to provide customized service, the data controller stores a small data package on the user's computer, the so-called cookies places it and reads it back during the next visit. A cookie is an alphanumeric information package with variable content sent by a web server and stored on the user's computer is recorded and stored for a predetermined validity period. 13. Data security

The Data Controller takes technical, organizational and organizational measures in view of the current state of technology ensures the protection of the security of data management, which is the risk arising in connection with data management provides an adequate level of protection.

We choose and operate the IT tools used to manage personal data in such a way that the managed data: accessible to those authorized to do so (availability); its authenticity and authentication are ensured (authenticity of data management); its immutability can be verified (data integrity); protected against unauthorized access (data confidentiality).



We protect the data with appropriate measures against accidental or illegal destruction, loss, alteration, against damage, unauthorized disclosure or unauthorized access. For personal data access is restricted by specifying authorization levels. We protect IT systems with a firewall and we provide virus protection. In the course of electronic data management, we ensure that the data is only used for a purpose, under controlled conditions, only those persons who need to do so in order to perform their duties have access to it they need. It is suitable for the protection of data files managed electronically in our various registers with a technical solution, we ensure that the stored data - unless permitted by law - is not directly they can be connected and assigned to the person concerned.

The Data Controller keeps a record of any data protection incidents, indicating the data protection incident related to it facts, its effects and the measures taken to remedy it. Any data protection incident is handled by the Data Controller without delay and, if possible, no later than 72 hours after becoming aware of the data protection incident, reports to the National Data Protection and Freedom of Information Authority, unless the data protection incident probably does not pose a risk to the rights and freedoms of natural persons.

14. The rights of data subjects and the conditions for their enforcement

We can request the correction, restriction, or deletion of our data at any time, and we can also request full data management specific information. We can also ask that you share our personal data broadly in accordance with the law we transfer it in a machine-readable format, or transfer our data to another data controller.

If you feel that Energofish Kft. violated the law during data management, the National can initiate an investigation.

Data Protection and Freedom of Information Authority (NAIH) with reference to the handling of personal data.

In connection with this, a violation of rights has occurred or there is an immediate risk of such violation, but we are happy to receive your complaint would be the first to contact us to investigate and remedy it as soon as possible.
